In 2011 The American Fallen Soldiers Project produced 31 hand-painted original portraits for the families of our fallen military service men and women from the wars in Iraq, Afghanistan and Vietnam. The original portraits were personally presented to the recipients across the United States in 24 specially organized public events that were designed to honor the fallen individual and their families, as well to help remind the communities where they were held of the sacrifices made for their freedom as an American citizen. This organization also produced over 100 canvas reproductions (fully framed) in varying sizes, as well as a multitude of photo prints, that were given to additional family members, friends and comrades of the fallen servicemen; as well as donated to other memorials requested by the families.
