Our organization makes available at no cost to the family an original portrait of their fallen loved one that fully captures their appearance and personality. In 2017 the organization produced 15 hand-painted original portraits for the families of America's military service members who lost their lives while serving in the wars in Iraq and Afghanistan. Each original portrait was presented to the respective family recipients during a special sponsored event designed to honor the fallen service member and their family, as well as to help remind the viewing audience of the sacrifice that has been paid for freedom.
